ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 14 OF THE CODE OF THE CITY OF TRENTON, "TRAFFIC, PARKING FOR THE HANDICAPPED."

BE IT ORDAINED, By the City Council of the City of Trenton that Chapter 14, Subsection 2.14 of the Code of the City of Trenton is hereby amended by adding to Schedule XIX, "Parking for the Handicapped," the following location:
