**II. Service Installation Agreement for applicants currently being served by a well.**

I understand that the removal of all well appurtenances shall comply with the NJDEP Safe Drinking Water Act regulation N.J.S.A. 58:12A-1 et. seq. and that noncompliance may result in a fine up to \$5,000.00. If I use a plumber to disconnect and remove my well system, I must inform him of these requirements. I am aware of the costs that I will incur to disconnect and remove my well system and its appurtenances (pump, tank, etc.) from the building or house plumbing. I realize that I will incur additional costs for installation of the water service pipe from the building or house to the curb stop valve and that this work must be coordinated with the Trenton Water Works' Meter Office at (609) 989-3225.

**III. Service Agreement.**

I hereby attest to my understanding that a service lateral (pipe) of a size equal to the size designated on this application together with the approved control valve shall be installed by TWW. The service lateral shall be installed from the water main to about eighteen inches beyond the property side of the curb or edge of pavement after I have had my plumbing installed from the inside of my premise or building to about eighteen inches from the property side of the curb or edge of pavement by my contractor.

I will not receive water service until the Meter Office installs the water meter and Trenton Water Works establishes service. If water service is established by any other person or entity other than Trenton Water Works, such action shall constitute Theft of Service and may result in legal action.

I hereby attest to my understanding that, if approved by Trenton Water Works, the owner shall be responsible for all costs associated with the water service identified in this application. I further attest to my understanding that if I (the Owner) place the responsibility of payment to my Tenant and my Tenant fails to make proper payment, I as the owner will be responsible for immediate full payment.
