

**AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT**

**THIS AMENDED AGREEMENT** made this 6th day of February 2017, by and between the **CITY OF TRENTON**, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **SAPONARO LAW GROUP**, The Newbold House 27 Cedar Street, Mount Holly, New Jersey 08060 (hereinafter "Law Firm").

**WHEREAS**, based upon the number of hours which the Law Firm has expended in the 2017 fiscal contract year in the performance of general and municipal litigation defense on behalf of the City; and

**WHEREAS**, the compensation initially allocated by the City to compensate the Law Firm has been deemed to be insufficient to the end of the fiscal contract year; and

**WHEREAS**, pursuant to Resolution **17-155**, the city desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2017,

**NOW THEREFORE**, the parties mutually agree as follows:

1. The compensation amount of the Agreement shall be increased by an amount not to exceed Sixty Thousand Dollars (\$60,000.00)
2. All other provisions of the Professional Legal Services Agreement executed on August 30, 2016 shall remain in full force and effect.





**RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WITH THE LAW OFFICE OF SAPONARO LAW GROUP, THE NEWBOLD HOUSE 27 CEDAR STREET, MOUNT HOLLY NJ 08060 TO PROVIDE CONTINUED PROFESSIONAL LEGAL SERVICES REGARDING GENERAL MUNICIPAL AND DEFENSE LITIGATION MATTERS IN AN AMOUNT NOT TO EXCEED \$60,000.00**

**WHEREAS**, the City of Trenton has a continuing need for professional legal services regarding General Municipal and Defense Litigation matters; and

**WHEREAS**, Resolution Number 16-493 awarded a contract to Saponaro Law Group in an amount not to exceed \$60,000.00 through RFP2016-13; and

**WHEREAS**, previously allocated funds has been exhausted and additional funds are necessary to cover services through June 2017; and

**WHEREAS**, this amendment shall be awarded to Saponaro Law Group in an amount not to exceed \$60,000.00; and

**WHEREAS**, funds for this contract have been certified to be available contingent upon temporary or final adoption of the FY2017 Budget in Account No. 7-01- -35-3500-290.

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend the contract with the Law Office of Saponaro Law Group for the said purposes in the manner prescribed by law.
