





RESOLUTION AMENDING THE CONTRACT WITH HMR ARCHITECTS, 821 ALEXANDER ROAD - SUITE 115, PRINCETON, NEW JERSEY 08540 FOR PROFESSIONAL ARCHITECTURAL AND ENGINEERING CONSULTANT SERVICES FOR THE REHABILITATION OF THE ALEXANDER DOUGLASS HOUSE, MILL HILL PARK, CITY OF TRENTON FOR THE CITY OF TRENTON, DEPARTMENT OF RECREATION, NATURAL RESOURCES, AND CULTURE

WHEREAS, Resolution 13-677 authorized the award of a contract with HMR Architects, 821 Alexander Road - Suite 115, Princeton, New Jersey 08540 for Professional Architectural and Engineering Consultant Services for the Rehabilitation of the Alexander Douglass House, Mill Hill Park; and

WHEREAS, the contractual duration was for the period December 20, 2013 through December 19, 2014 in the amount of \$80,280.00; and

WHEREAS, delays due to changes in project design outside the control of HMR prevented completion of the contract within the timeframe provided; and

WHEREAS, the need arises to amend the contract with HMR to enable them to complete the terms of the contract beyond the expiration of the original contract; and

WHEREAS, HMR shall complete its professional architectural and engineering services without the need for additional funding; and

WHEREAS, the changes will not alter the contract in such a manner as to nullify the effect of the competitive determination which was made at the time of the contract award;

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

RESOLUTION

1. The Mayor is hereby authorized to execute an amended contract with HMR to enable them to complete the professional architectural and engineering services for the Rehabilitation of the Alexander Douglass House, Mill Park.
2. The amended contract shall remain in full force for a duration of nine (9) months from the contract date and shall not be extended without approval of the City Council of the City of Trenton.

**AMENDMENT TO RESOLUION 15-125
TO EXTEND THE CONTRACT WITH HMR ARCHITECTS**

THE AMENDED AGREEMENT made this 19TH day of March 2015, by and between the **CITY OF TRENTON**, a Municipal Corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and (**HMR ARCHITECTS**), with principal offices located 821 Alexander Road-Suite 115, Princeton, NJ 08540 (hereinafter "Professional Architectural and Engineering Consulting Services").

WHEREAS, HMR Architects has assisted the City of Trenton to Provide, and Engineering Consultant Services for Rehabilitation of the Alexander Douglass House, Mill Hill Park, City of Trenton; and

WHEREAS, the contract duration was for the period of December 20, 2013 through December 19, 2014 in the amount of \$80,280.00 and

WHEREAS, pursuant to Resolution 15-125, the City of Trenton desires to extend the contract for a period of one year from December 20, 2014 through December 19, 2015.

NOW THEREFORE, the parties mutually agree as follows:

1. The Mayor is hereby authorized to execute an amended contract with HMR Architects to enable them to complete the professional architectural and engineering consultant services for the rehabilitation of the Alexander Douglass House, Mill Hill Park.
2. The amended contract shall remain in full force a duration of twelve (12) months from the contract date and shall not be extended without approval of the City Council of the City of Trenton.
