RESOLUTION AMENDING RESOLUTION 13-15 TO INCREASE THE AMOUNT AWARDED TO INTERNATIONAL SALT, INC, 655 NORTHERN BLVD, CLARKS SUMMIT, PA 18411 BY \$300,000.00 FOR FURNISHING AND DELIVERY OF TREATED ROCK SALT FOR THE CITY OF TRENTON; IN CONJUNCTION WITH THE COUNTY OF MERCER COOPERATIVE CONTRACT PURCHASING SYSTEM FROM DECEMBER 22, 2013 TO FEBRUARY 12, 2014

WHEREAS, Resolution 13-15 adopted January 3, 2013 to furnish and deliver treated rock salt for the City of Trenton as a cooperative contract purchasing agreement with the County of Mercer as the lead Agency; and

WHEREAS, the City has a need to increase the amount awarded by \$300,000.00 to International Rock Salt, Inc., 655 Northern Blvd., Clarks Summit, PA 18411 from \$112,500.00 to \$412,500.00; complying with the terms and specifications on file in the Division of Purchasing; and

WHEREAS, funds in an additional amount of \$300,000.00 have been certified to be available in account number 04-01- -55-5520-309 from December 22, 2013 through February 12, 2014 which is contingent upon the adoption of the temporary or final budget for FY 2014.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute an extended contract with International Rock Salt, Inc, 655 Northern Blvd., Clarks Summit, PA 18411 for the said purposes and good cause in the manner prescribed by law.
