

RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR TWO YEARS TO LANDOLFI ELECTRIC COMPANY, INC., 213 BUNTING AVENUE, TRENTON, NEW JERSEY 08611 FOR EMERGENCY ELECTRICAL SERVICES FOR THE TRENTON SEWER UTILITY AT A RATE OF \$85.00/HOUR IN AN AMOUNT NOT TO EXCEED \$40,000.00 PER YEAR – BID 2015-33

WHEREAS, Resolution 15-496 awarded a contract on August 6, 2015 to Landolfi Electric Company, Inc., 213 Bunting Avenue, Trenton, New Jersey 08611 for a period of one (1) year for Emergency Electrical Services for the Department of Public Works, Division of Sewer Utility; and

WHEREAS, Resolution 16-257 amended Resolution 15-496 in order to accurately reflect the original bid specification, which stipulated the contract would be for a period of two (2) years with an option for one additional two (2) year extension as is allowed per; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 (d) the terms and conditions of the contract remains substantially the same for a period of two (2) years with the option to extend two (2) years; therefore, it is the best interest of the City of Trenton to award a two (2) year extension with Landolfi Electric, Co., Inc., 213 Bunting Ave, Trenton, NJ 08611; and

WHEREAS, The current two (2) year contract for said services has expired as of August 5, 2017 and the vendor, Landolfi Electric Company, Inc. has indicated by Letter of Agreement its desire to continue to provide Emergency Electrical Services for Trenton Sewer Utility for two (2) additional years under the auspices of the original bid documents from time of award through August 5, 2019; and


WHEREAS, Funding for these services will be available in budget account (s) 8-07- -55-5500-270 and 9-07- -55-5500-270 in amounts not to exceed \$40,000.00 per year contingent upon the adoption FY'2018 final budget and FY'2019 temporary and or final budget.



**RESOLUTION # 17-752
EXERCISING THE OPTION TO EXTEND A CONTRACT
WITH LANDOLFI ELECTRICAL COMPANY, INC.
BID2015-33**

THE AGREEMENT made this 3rd Day of NOVEMBER 2017, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **LANDOLFI ELECTRICAL COMPANY, INC., 213 BUNTING AVENUE, TRENTON, NEW JERSEY 08611** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 15-496 awarded a contract on August 06, 2015, to Landolfi Electrical Company, Inc., 213 Bunting Avenue, Trenton, New Jersey 08611 for a period of one (1) year for Emergency Electrical Services for the City of Trenton for the Department of Public Works, Division of Sewer Utility; and

WHEREAS, Resolution No. 16-257 amended Resolution No. 15-496 in order to accurately reflect the original bid specification, which stipulated the contract would be for a period of two (2) years with an option for one (1) additional two (2) year extension in an amount not to exceed \$40,000.00; per N.J.S.A. 40A:11-15 the terms and conditions of the contract remain substantially the same; and

WHEREAS, Resolution No. 17-752 dated November 3, 2017, authorized to exercise the option to extend the contract for two (2) additional years from August 6, 2017 to August 5, 2019 in an amount not to exceed \$40,000.00; per the original bid specifications filed in the Division of Purchasing.

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall not to exceed \$85.00 per hour in an amount not to exceed \$40,000.00 from August 6, 2017 through August 5, 2019.
2. The Mayor is hereby authorized to exercise the option to extend contract for two (2) years from August 6, 2017 to August 5, 2019 with Landolfi Electrical Company, Inc., 213 Bunting Avenue, Trenton, New Jersey 08611 for said purposes in the manner prescribed by law.
