**RESOLUTION AUTHORIZING A CONTRACT EXTENSION WITH RIGGINS, INC.,  
P.O. BOX 150, MILLVILLE, NEW JERSEY 08360 FOR THE FURNISHING AND DELIVERY OF  
UNLEADED 87 OCTANE GASOLINE ON AN AS NEEDED BASIS FOR VARIOUS  
DEPARTMENTS THROUGH NEW JERSEY STATE CONTRACT NO. T-0083 A80909  
IN AN AMOUNT NOT TO EXCEED \$103,335.00**

**WHEREAS**, Resolution Number 16-97 extended a contract to Riggins, Inc. for the furnishing and delivery of unleaded 87 octane gasoline on an as needed basis to various departments in the City of Trenton for the City of Trenton from March 1, 2016 to February 28, 2017 in an amount not to exceed \$930,000.00 through State Contract A80909; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0083 A80909 based on Oil Price Information Service (OPIS) for the date of the fuel plus a constant up at a cost per gallon of \$1.5231 plus a constant delivery charge of \$.105 from March 1, 2017 through August 31, 2017 entitled gasoline, automotive meeting the requirements of the City of Trenton; and

**WHEREAS**, the City of Trenton has determined that Riggins, Inc., P.O. Box 150, Millville, NJ 08360 has performed its services in a satisfactorily manner and it is in the best interest of the City to extend the contract for the furnishing and delivery of gasoline, automotive on an as needed basis through New Jersey State Contract No T-0083 A80909 in an amount not to exceed \$103,335.00 from March 1, 2017 through August 31, 2017.
