**RESOLUTION AUTHORIZING A CONTRACT WITH SAMZIE'S UNIFORMS, 28 SCOTCH ROAD, EWING, NEW JERSEY 08628 FOR THE PURCHASE OF FORTY-ONE (41) BULLETPROOF VESTS WITH NEW JERSEY STATE CONTRACT NO. T-0106 A-81348, LINE#00110 FROM MAY 01, 2012 TO AUGUST 28, 2017 IN AN AMOUNT NOT TO EXCEED \$53,109.35**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items and provide services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0106 A81348, Line#00110 for Police and Homeland Security Equipment and Supplies awarded from May 01, 2012 to August 28, 2017 meeting the requirements of the City of Trenton, Department of Police; and

**WHEREAS**, the purchase of Forty-one (41) Bulletproof Vests shall be purchased through New Jersey State Contract No. T-0106 A81348, Line#00110 from Samzie's Uniform, 28 Scotch Road, Ewing, New Jersey 08628 in an amount not to exceed of \$53,109.35 for the City of Trenton, Department of Police; and

**WHEREAS**, funds in an amount not to exceed \$53,109.35 have been certified to be available in grant account(s): G-FF-16-50-231G-333 (\$9,721.98), G-FF-17-50-231G-333 (\$16,832.95), G-SS-16-50-911G-333 (23,485.01), and G-SS-17-50-911G-333 (\$3,069.41).

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$53,109.35 for the purchase of Forty-one (41) Bulletproof Vests through New Jersey State Contract No. T-0106 A81348, Line#00110 to Samzie's Uniform, 28 Scotch Road, Ewing, New Jersey 08628 for the City of Trenton, Department of Police.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
