

Councilman /woman *Zachary A. Chester* presents the following Resolution:

RESOLUTION EXERCISING THE OPTION TO EXTEND A CONTRACT FOR ONE YEAR TO ZOMPARELLI CONTRACTORS, LLC, 11 MICHAEL MCCORRISTIN ROAD, TRENTON, NEW JERSEY 08690 FOR REPLACEMENT OF SIDEWALKS, DRIVEWAY APRONS AND CURBS FOR THE DIVISION OF TRAFFIC AND TRANSPORTATION IN AN AMOUNT NOT TO EXCEED \$150,000.00 -BID2015-37

WHEREAS, Resolution Number 15-482 awarded a contract on August 7, 2015 to Zomparelli Contractors, LLC, 11 Michael McCorristin Rd., Trenton, NJ 08690 for replacement of sidewalks, driveway aprons and curbs for the Department of Public Works, Division of Traffic and Transportation for a period of one (1) year from August 7, 2015 to August 6, 2016; and

WHEREAS, Resolution Number 16-718 adopted on November 22, 2016 amended Resolution No. 15-482 which failed to state the option to extend one (1) year per the original bid specifications filed in the Division of Purchasing; and



WHEREAS, N.J.S.A.40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Public Works, Division of Traffic and Transportation has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for one (1) year to Zomparelli Contractors, LLC, 11 Michael McCorristin Rd., Trenton, NJ 08690 per N.J.S.A.40A:11-15. The one year renewal shall commence August 7, 2016 to August 6, 2017; and

WHEREAS, funds in an amount not to exceed \$150,000.00 has been certified to be available in account C-04-13-65-018A-001.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for one (1) year with Zomparelli Contractors, LLC, 11 Michael McCorristin Rd., Trenton, NJ 08690 in an amount not to exceed \$150,000.00 from August 7, 2016 to August 6, 2017 for the City of Trenton, Department of Public Works, Division of Traffic and Transportation for the said purposes in the manner prescribed by law.

**RESOLUTION # 17-75
EXERCISING THE OPTION TO EXTEND A CONTRACT
WITH ZOMPARELLI CONTRACTORS, LLC
BID2015-37
PREVAILING WAGE APPLIES**

THE AGREEMENT made this 17TH day of February 2017, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **ZOMPARELLI CONTRACTORS, LLC, 11 MICHAEL MCCORRISTIN ROAD, TRENTON, NEW JERSEY 08690** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 15-482 dated August 6, 2015, awarded a contract to Zomparelli Contractors, LLC, 11 Michael McCorristin Road, Trenton, NJ 08690 for a period of one (1) year from August 7, 2015 to August 6, 2016 in an amount not to exceed \$150,000.00; for the replacement of sidewalks, driveway aprons and curbs at various locations within the City of Trenton for the Department of Public Works, Division of Traffic and Transportation.

WHEREAS, Resolution No. 16-718 dated November 22, 2016, amended Resolution No. 15-482 which failed to state for a period of one (1) year with an option to extend one (1) year in an amount not to exceed \$150,000.00; per the original bid specifications filed in the Division of Purchasing; and

WHEREAS, Resolution No. 17-75 dated February 16, 2017, authorized to exercise the option to extend the contract for one (1) year from February 17, 2017 to February 16, 2018 in an amount not to exceed \$150,000.00; per the original bid specifications filed in the Division of Purchasing.

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$150,000.00.
2. The Mayor is hereby authorized to exercise the option to extend the contract with Zomparelli Contractors, LLC, 11 Michael McCorristin Road, Trenton, NJ 08690 from February 17, 2017 to February 16, 2018 for said purposes in the manner prescribed by law.
