**RESOLUTION EXERCISING THE OPTION TO EXTEND CONTRACT FOR YEAR TWO TO ACCURATE WASTE REMOVAL SERVICES, 226 PROSPECT POINT ROAD, LAKE HOPATCONG, NEW JERSEY 07849 FOR DAILY WASTE REMOVAL AND DISPOSAL OF LIQUID SLUDGE FROM DIGESTER TANKS IN AN AMOUNT NOT TO EXCEED \$1,077,440.00 -BID2015-41**

**WHEREAS**, Resolution Number 16-256 amended the contract on September 17, 2015 to Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey 07849 for daily waste removal and disposal of liquid sludge from digester tanks, for the Department of Public Works, Trenton Sewer Utility for a period of one (1) from July 1, 2016 to June 30, 2017 with the option to extend two (2) one (1) year options per original bid specifications filed in the Division of Purchasing; and

**WHEREAS**, N.J.S.A.40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and


**WHEREAS**, the City of Trenton, Department of Public Works, Trenton Sewer Utility has determined that the vendor has performed its services in a satisfactory manner and it is in the best interest of the City to extend the contract for year two to Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey 07849 per N.J.S.A.40A:11-15. The two year renewal will commence on July 1, 2016 to June 30, 2017; and



CONTRACT EXERCISING THE OPTION TO EXTEND YEAR TWO (2) WITH ACCURATE  
WASTE REMOVAL SERVICES**

**THE AGREEMENT** made this 22<sup>ND</sup> day of JULY 2016, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **ACCURATE WASTE REMOVAL SERVICES, 226 PROSPECT ROAD, LAKE HOPATCONG, NEW JERSEY 07849** (hereinafter "CONTRACTOR")

**WHEREAS**, Res. No. 16-256 amended the contract on September 17, 2015 to Accurate Waste Removal Services, 226 Prospect St., Lake Hopatcong, NJ 07849 for Daily Waste Removal and Disposal of Liquid Sludge from Digester Tanks from July 1, 2016 to June 30, 2017 with an option to extend two (2) one (1) year options per original bid specifications; and

**WHEREAS**, Resolution 16-455 authorized the option to extend the contract for year two (2) per the original bid specifications filed in the Division of Purchasing.

**NOW THEREFORE**, the parties mutually agree as follows:

1. The option to extend shall be in an amount not to exceed \$1,077,440.00; the renewal shall commence on July 1, 2016 to June 30, 2017.
2. The Mayor is hereby authorized to exercise the option to extend the contract with Accurate Waste Removal Services, 226 Prospect St., Lake Hopatcong, NJ 07849 for set purposes in manner prescribed by law.
