*\* There is no additional removal fee. Both the installation and removal are included in the initial rate.*

Example:

A property that requires 10 window guards and 2 door guards:

Initial Cost (1<sup>st</sup> Month)

Installation Cost - \$250 = (10x\$20) + (2x\$25)

One Month Rental Cost - \$150 = (10x\$10) + (2x\$25)

Initial Total Cost: \$400.00

Additional One Month Rentals

\$150 = (10x\$10) + (2x\$25)
