RESOLUTION EXERCISING THE FINAL ONE (1) YEAR OPTION TO EXTEND A CONTRACT WITH QUAL-LYNX, 100 DECADON DRIVE, EGG HARBOR TOWNSHIP, NEW JERSEY 08234 TO CONTINUE TO PROVIDE WORKER'S COMPENSATION MANAGED CARE SERVICES FOR THE CITY OF TRENTON, DEPARTMENT OF ADMINISTRATION; PROVIDER NETWORK ACCESS AT 20% OF SAVINGS FROM USUAL CUSTOMARY FEES (UCR), FIELD CASE MANAGEMENT FEES PLUS EXPENSES (TRAVEL) AT \$75.00 PER HOUR AND \$75.00 FOR NURSE CASE MANAGEMENT (FOR ASSIGNED FILES ONLY) SHALL BE PAID BY THE THIRD PARTY ADMINISTRATOR PROVIDER

WHEREAS, Resolution 15-144 awarded a contract to Qual-Lynx, 100 Decadon Drive, Egg Harbor Township, NJ 08234 through a competitive contracting process to provide worker's compensation managed care services for a period of one (1) year from March 1, 2015 to February 29, 2016 with the option to extend two (2) one (1) year options for the City of Trenton, Department of Administration; and



WHEREAS, Resolution 16-74 authorized to exercise the option to extend the contract for a period of one (1) year commencing on March 1, 2016 through February 28, 2017; and

WHEREAS, it is in the best interest of the City of Trenton to extend the current contract for the final one (1) year under the provisions of N.J.S.A.40A:00-15 with Qual-Lynx, 100 Decadon Drive, Egg Harbor Township, New Jersey 08234 for Worker's Compensation Services who has performed its services in a satisfactorily manner. The final one (1) year extension shall commence on March 1, 2017 through February 28, 2018; and

WHEREAS, no funds need to be certified for this procurement. Provider Network Access at 20% of savings from usual customary fees (UCR), field case management fees plus expenses (travel) at \$75.00 per hour for nurse case management (for assigned files only) shall be paid by the Third Party Administrator Provider.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the final one (1) year option to extend the contract with Qual-Lynx, 100 Decadon Drive, Egg Harbor Township, New Jersey 08234 for the said purposes in the manner prescribed by law.

FINAL OPTION TO EXTEND WITH QUAL-LYNX

THE AGREEMENT made this 10TH day of MARCH 2017, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **QUAL-LYNX, 100 DECADON DRIVE, EGG HARBOR TOWNSHIP, NEW JERSEY 08234** (hereinafter "**CONTRACTOR**")

WHEREAS, Res. No. 15-144 awarded of a contract to Qual-Lynx, 100 Decadon Drive, Egg Harbor Township, NJ 08234 through a competitive contract to provide Worker's Compensation Services for a period of one (1) year from (March 1, 2015 to February 29, 2016) with the option to extend two (2) one (1) year options for the City of Trenton Department of Administration; and

WHEREAS, Resolution 16-74 exercised the option to extend the contract for one year as per the original bid specifications filed in the Division of Purchasing from May 1, 2016 to February 28, 2017.

WHEREAS, Resolution 17-88 exercised the final one (1) year option to extend the contract as per the original bid specifications filed in the Division of Purchasing from March 1, 2017 to February 28, 2018.

NOW THEREFORE, the parties mutually agree as follows:

1. The final option to extend the contract to provide Workers' Compensation, Managed Care Services at 20% of Savings from Usual Customary Fees (UCR), Field Case Management Fees plus Expenses (Travel) at \$75.00 per hour and \$75.00 for Nurse Case management (For Assigned Files Only) shall be paid by the Third Party Administrator from March 1, 2017 to February 28, 2018 for the City of Trenton, Department of Administration.
2. The Mayor is hereby authorized to execute the final option to extend the contract for One (1) Year to Qual-Lynx, 100 Decadon Drive, Egg Harbor Township, New Jersey 08234 for said purposes in the manner prescribed by law.
