



**RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2015 EBONY BLACK POLICE INTERCEPTOR UTILITY, ALL WHEEL DRIVE FOR THE DEPARTMENT OF ADMINISTRATION FROM WINNER FORD, 250 HADDONFIELD BERLIN ROAD, CHERRY HILL, NEW JERSEY 08034-3409 THROUGH NEW JERSEY STATE CONTRACT NO. A82925 FROM OCTOBER 25, 2012 TO OCTOBER 24, 2014 IN AN AMOUNT NOT TO EXCEED \$28,898.56**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2776 No. A82925 for Police Vehicles, Sedans and Sport Utility Vehicles meeting the requirements of the City of Trenton; and

**WHEREAS**, one (1) 2015 Ebony Black Police Interceptor Utility, All Wheel Drive for the Department of Administration will be purchased under New Jersey State Contract T-2776 No. A82925 from Winner Ford, 250 Haddonfield Berlin Road, Cherry Hill, New Jersey 08034-3409 in an amount not to exceed of \$28,898.56 from October 12, 2012 through October 24, 2014; and

**WHEREAS**, funds in an amount not to exceed \$28,898.56 have been certified to be available in account number C04-99-25-007G-00 (\$18,576.95) and C-04-06-25-086L-024 (\$10,321.61) contingent upon the availability of sufficient funds and the adoption of the FY 2015 temporary or final budget.


**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:



2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
