RESOLUTION EXERCISING THE OPTION TO EXTEND A CONTRACT WITH PRIMEPOINT, 2 SPRINGSIDE ROAD, MOUNT HOLLY, NEW JERSEY 08060 FOR SIX MONTHS TO CONTINUE TO PROVIDE PAYROLL AND HUMAN RESOURCE INFORMATION SYSTEM SERVICES FOR THE CITY OF TRENTON IN AN AMOUNT NOT TO EXCEED \$65,000.00

WHEREAS, Resolution Number 16-60 awarded an emergency contract for a period of one (1) year on February 18, 2016 to Primepoint, 2 Springside Road, Mount Holly, NJ 08060 to continue to provide Payroll and Human Resource Information Systems for up to one year from the date of award beginning February 1, 2016 to January 31, 2017 for the City of Trenton, Department of Administration; and

WHEREAS, due to the emergent need of Payroll and Human Resource Information System Services, the City of Trenton seeks to contract the services to Primepoint, 2 Springside Road, Mt. Holly, New Jersey 08060 under N.J.S.A.40A:11-6 for a period of six (6) months beginning February 1, 2017 to July 1, 2017 until a fair and open procurement process can be completed; and

WHEREAS, the City of Trenton desires to extend the award of a six month contract to Primepoint, 2 Springside Road, Mt. Holly, NJ 08060 in the amount not to exceed \$65,000.00; and

WHEREAS, funds in an amount not to exceed \$65,000.00 has been certified to be available in account (s) 7-01--25-2540-290 contingent upon the adoption FY'2017 temporary and or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to award a contract to Primepoint, 2 Springside Road, Mount Holly, NJ 08060 to continue to provide Payroll and Human Resource Information Systems for a period of six months beginning February 1, 2017 to July 1, 2017 in an amount not to exceed \$65,000.00 for the City of Trenton, Department of Administration for the said purposes in the manner prescribed by law.

**RESOLUITON # 17-29
CONTRACT WITH PRIME POINT, LLC**

THE AGREEMENT made this 6th day of January 2017, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **PRIME POINT, LLC, 2 SPRINGSIDE ROAD, MOUNT HOLLY, NEW JERSEY 08060** (hereinafter "CONTRACTOR")

WHEREAS, Res. No. 16-60 awarded an emergency contract under N.J.S.A. 40:A 11-6 on an emergency basis to Prime Point, LLC, 2 Springside Rd., Mt. Holly, NJ 08060 to continue to provide Payroll and Human Resource Information System Services for the period of one (1) year or until a fair and open procurement process can be completed; and

WHEREAS, pursuant to Resolution 17-29 terms of the contract shall be awarded for a period of six (6) months beginning February 1, 2017 to July 1, 2017 or until a fair and open procurement process can be completed in an amount not to exceed \$65,000.00.

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$65,000.00.
2. The Mayor is hereby authorized to extend the current contract for an additional six (6) months from February 1, 2017 to July 1, 2017 or until a fair and open procurement process can be completed with Prime Point, LLC, 2 Springside Rd., Mt. Holly, NJ 08060 for said purposes in the manner prescribed by law.
