RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) 2017 FORD POLICE INTERCEPTOR UTILITY ALL WHEEL DRIVE STAFF EMERGENCY RESPONSE VEHICLES AWARDED TO CHAS S. WINNER, INC., DBA WINNER FORD, 250 BERLIN ROAD, CHERRY HILL, NEW JERSEY 08034 THROUGH NEW JERSEY STATE CONTRACT NO. T-2776 88728 IN AN AMOUNT NOT TO EXCEED \$68,138.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-2776 88728 for Police Vehicles: Sedans, Sport Utility Vehicles and Trucks, from March 16, 2015 to March 15, 2017 meeting the requirements of the City of Trenton, Fire Department; and

WHEREAS, two (2) 2017 Ford Interceptor Utility All Wheel Drive Staff Emergency Response Vehicles for Trenton Fire Department will be purchased under New Jersey State Contract No. T-2776 88728 awarded to Chas S. Winner Inc., DBA Winner Ford, 250 Berlin Road, Cherry Hill, New Jersey 08034 in an amount not to exceed of \$68,138.00; and
