RESOLUTION AUTHORIZING THE PURCHASE OF ONE HUNDRED (100) WORKSTATION DESKTOP COMPUTERS AND ACCESSORIES AWARDED TO GOLD TYPE BUSINESS MACHINES, INC., 351 PATERSON AVENUE, EAST RUTHERFORD, NEW JERSEY 07073 THROUGH NEW JERSEY STATE CONTRACT NO. M0483 89980 IN AN AMOUNT NOT TO EXCEED \$82,399.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, funds in an amount not to exceed \$82,399.00 have been certified to be available in account C-04-16-50-035d-001.


NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:
