



**RESOLUTION AMENDING THE AMOUNT OF THE CONTRACT WITH BEYER FORD, 170 BRIDGEDALE AVENUE, MORRISTOWN, NEW JERSEY 07960 FOR THE PURCHASE OF ONE (1) 2016 BLUE FORD F-250 4wd 4X4 XLS REGULAR CAB 137 WB WITH SNOW PLOW, SALT SPREADER, BACK-UP SENSOR AND VARIOUS SAFETY ITEMS THROUGH THE NEW JERSEY STATE CONTRACT NO. T-2102 A88727 FOR THE TRENTON WATER UTILITY IN THE AMOUNT NOT TO EXCEED \$35,006.00.**

**WHEREAS**, Resolution Number 16-98 authorized a contract with Beyer Ford for the purchase of a Blue Ford F-250 in the amount of \$35,006.00; and

**WHEREAS**, due to the time lapse from the recommendation of award to the issuance of an award resolution the 2016 model Ford F-250 is no longer available; and

**WHEREAS**, the need arises to amend the contract with Beyer Ford to reflect the purchase of a 2017 model Ford F-250 vehicle which has a cost difference in the amount of \$499.00; and

**WHEREAS**, the changes will not alter the contract in such a way as to nullify the effect of the purchase under New Jersey State Contract T-2102 A88727 ; and


**WHEREAS**, funding has been certified to be available in C-06-15-55-039A-392 in the amount of \$499.00;

**NOW, THEREFORE IT IS RESOLVED**, by the City Council of the City of Trenton that the Mayor is hereby authorized to execute an amended contract with Breyer Ford, 170 Bridgedale Avenue, Morristown, New Jersey 07960 in an amount not to exceed \$35,505.00
