

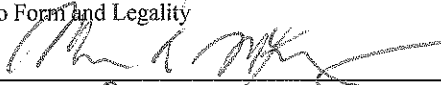

**RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF WIRELESS EQUIPMENT THOUGHOUT CITY HALL AWARDED TO NEW JERSEY BUSINESS SYSTEMS, INC., 7C MARLEN DRIVE, ROBBINSVILLE, NEW JERSEY 08691, THROUGH NEW JERSEY STATE CONTRACT NO. T-0109 A83899 IN AN AMOUNT NOT TO EXCEED \$96,982.78**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0109 A83899 for Radio Communication Equipment and Accessories Services awarded to New Jersey Business Systems, Inc., 7C Marlen Drive, Robbinsville, New Jersey 08691 as the requirements of the City of Trenton, Department of Administration/IT; and

**WHEREAS**, the purchase and installation of wireless equipment and accessories will be purchased under New Jersey State Contract #T-0109 A83899, in an amount not to exceed of \$96,982.78; and

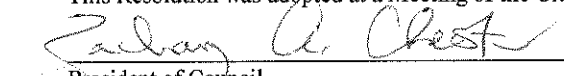
**WHEREAS**, funds in an amount not to exceed \$96,982.78 have been certified to be available in account number C-04-16-25-035D-007.

The Purchasing Agent is hereby authorized to execute a purchase order to New Jersey Business Systems, Inc., 7C Marlen Drive, Robbinsville, New Jersey 08691 in an amount not to exceed \$96,982.78, for the purchase and installation of wireless equipment and accessories throughout City Hall as the requirements of the City of Trenton, Department of Administration/IT.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
