





RESOLUTION AUTHORIZING THE PURCHASE OF PERSONAL PROTECTION EQUIPMENT (PPE) AWARDED TO SUPPLIER READING FIRE EQUIPMENT, INC., 2200 PERKIOMEN AVENUE, READING PENNSYLVANIA 19606 THROUGH THE NEW JERSEY STATE CONTRACT NO. T-0790 A88839, BEGINNING APRIL 1, 2012 TO MARCH 31, 2017 IN AN AMOUNT NOT TO EXCEED \$66,867.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Department of Fire and Emergency Service is in the process of hiring 20 new Firefighters, as a result all 20 Firefighters must be outfitted with the proper PPE as outlined in N.J.A.C 1200 and N.F.P.A 1851 as well as PEOSH regulations; and.

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0790 88839 for Personal Protection Equipment from beginning, April 1, 2012 through March 31, 2017; meeting the requirements of the City of Trenton, Department of Fire and Emergency Services; and

WHEREAS, the purchase of Personal Protection Equipment and accessories will be purchase from Reading Fire Equipment, Inc., 2200 Perkiomen Ave, Reading, PA 19606 in an amount not to exceed of \$66,867.00 for the City of Trenton, Department of Fire and Emergency Services; and

WHEREAS, funds in an amount not to exceed \$66,867.00 have been certified to be available in account number 7-01--45-4500-303, contingent upon the adoption of FY'2017 temporary/final budget.


NOW, THEREFORE, IT IS RESOLVED, by the City of Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Reading Fire Equipment, Inc., 2200 Perkiomen Ave, Reading, PA 19606 in an amount not to exceed \$66,867.00 for the purchase of Personal Protection Equipment (PPE) for the new firefighters of the City of Trenton, Department of Fire and Emergency Services.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
