RESOLUTION AWARDING A PROFESSIONAL SERVICES CONTRACT THROUGH A FAIR & OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44 A-20.4 ET SEQ TO SOVEREIGN CONSULTING, 111-A NORTH GOLD DRIVE, ROBBINSVILLE, NEW JERSEY 08691 FOR ENVIRONMENTAL ENGINEERING SERVICES – HETZEL FIELD PARK IMPROVEMENTS IN AN AMOUNT NOT TO EXCEED \$207,782.58 - RFP2015-16

WHEREAS, the City has a need for Environmental Engineering Services – Hetzel Field Park Improvements for the City of Trenton, Department of Recreation, Natural Resources and Culture for a period of one year; and

WHEREAS, a request for proposal was advertised, and fourteen (14) proposals were received on May 18, 2015 and were evaluated by a committee based on criteria that included experience, understanding of requirements and cost; and

WHEREAS, the proposal of Sovereign Consulting, 111-A North Gold Drive, Robbinsville, New Jersey 08691 was deemed to include the necessary qualifications and expertise for the performance of the services at the rates listed in the proposal; and

WHEREAS, funds in an amount not to exceed \$207,782.58 have been certified to be available in account number C-04-10-60-035B-002.

NOW, THEREFORE IT IS RESOLVED, by the City Council of the City of Trenton, as follows:

1. The Mayor is hereby authorized to enter into a professional services contract with Sovereign Consulting, 111-A North Gold Drive, Robbinsville, New Jersey 08691 for a period of one year; in an amount not to exceed \$207,782.58.
2. This contract is awarded pursuant to the authority set forth in the Local Public Contract Law at N.J.S.A. 40A:11-4.1.
3. A notice of this action shall be printed once in the official newspaper for the City of Trenton and the Resolution and contract shall remain on file in the City Clerk's Office.
