

AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT

THIS AMENDED AGREEMENT made this 17th day of March 2016, by and between the **CITY OF TRENTON**, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **Parker McCay, P.A.**, 9000 Midlantic Drive, P.O. Box 300, Mount Laurel, New Jersey 08054 (hereinafter "Law Firm").

WHEREAS, based upon the number of hours which the Law Firm has expended in the 2017 fiscal contract year in the performance of general and municipal litigation defense on behalf of the City; and

WHEREAS, the compensation initially allocated by the City to compensate the Law Firm has been deemed to be insufficient to the end of the fiscal contract year; and

WHEREAS, pursuant to Resolution **16-685**, the city desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2017,

NOW THEREFORE, the parties mutually agree as follows:

1. The compensation amount of the Agreement shall be increased by an amount not to exceed Sixty Thousand Dollars (\$60,000.00)
2. All other provisions of the Professional Legal Services Agreement executed on August 30, 2016 shall remain in full force and effect.

WHEREAS, this amendment shall be awarded to Parker McCay, P.A. in an amount not to exceed \$60,000.00; and

WHEREAS, funds for this contract have been certified to be available contingent upon temporary or final adoption of the FY2017 Budget in Account No. 7-01- -35-3500-290; and


