RESOLUTION AUTHORIZING THE PURCHASE, DELIVERY, INSTALLATION AND LICENSE OF AN UPGRADED SECURITY SYSTEM FOR CITY HALL AWARDED TO SHI INTERNATIONAL CORP, 290 DAVIDSON AVENUE, SOMERSET, NEW JERSEY 08873 THROUGH NEW JERSEY STATE CONTRACT NO. M-0003 89851 IN AN AMOUNT NOT TO EXCEED \$230,593.99

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract M-0003 89851 for Software License and Related SER awarded to SHI International, Corp., 290 Davidson Avenue, Somerset, New Jersey 08873 from September 1, 2015 to June 30, 2020 meeting the requirements of the City of Trenton; and

WHEREAS, the purchase, delivery, installation and license for an upgraded security system that consists of an access control, video recording, and visitor management system for City Hall. The purchase will be made through New Jersey State Contract M-0003 89851 in an amount not to exceed of \$230,593.99; and

WHEREAS, funds in an amount not to exceed \$230,593.99 have been certified to be available in the following capital account numbers: C-04-08-25-079D-007 (\$139,079.65), C-04-06-25-086D-006 (\$18,397.09), C-04-07-25-102D-009 (\$48,454.59) and C-04-08-25-079D-005 (\$24,662.66).


NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.




