RESOLUTION AUTHORIZING THE PURCHASE OF HOT MIX ASPHALT FROM AMERICAN ASPHALT CO., INC., 116 MAIN STREET, WEST COLLINGSWOOD HEIGHTS, NEW JERSEY 08059 THROUGH NEW JERSEY STATE CONTRACT NO. T-0155 A86421 IN AN AMOUNT NOT TO EXCEED \$276,582.62

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0155 A86421 Hot Mix Asphalt (HMA), pick-up only for NJDOT & pick-up/delivery for other agencies from August 18, 2016 to April 30, 2017 meeting the requirements of the City of Trenton; and

WHEREAS, Hot Mix Asphalt shall be purchased through New Jersey State Contract No. T-0155 A86421 from American Asphalt Co., Inc., 116 Main Street, West Collingswood Heights, New Jersey 08059 in an amount not to exceed \$276,582.62; and

WHEREAS, funds in an amount not to exceed \$276,582.62 have been certified to be available in the following account number C-04-15-55-040C-003.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Trenton, as follows:


