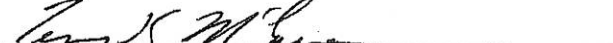

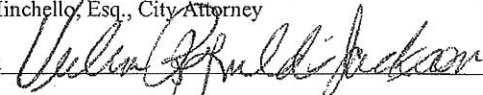

Councilman /woman  presents the following Resolution:

RESOLUTION AUTHORIZING THE RENTAL OF A SHARP MX-M464N NETWORKED DIGITAL COPIER FOR THE DIVISION OF PURCHASING FROM SHARP ELECTRONICS, CORP, ONE SHARP PLAZA, MAHWAH, NEW JERSEY 07430 THROUGH NEW JERSEY STATE CONTRACT M-0053 NO. A82710 FOR A PERIOD OF FORTY EIGHT (48) MONTHS FOR A MONTHLY RENTAL FEE OF \$207.13 IN AN AMOUNT NOT TO EXCEED \$9,942.24

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items /services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract M-0053 No.A82710 for New Jersey Cost per Copy meeting the requirements of the City of Trenton; and

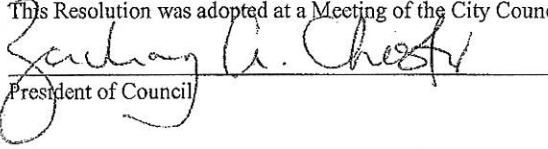
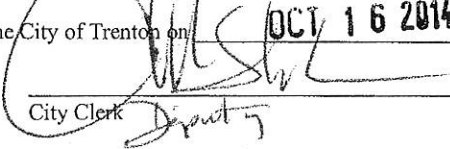
WHEREAS, One (1) Sharp MX-M464N Networked Digital Copier, Scanner, Printer with all parts, labor, toner and drums will be rented under New Jersey State Contract M-0053 No. A82710 from Sharp Electronics, Corp, One Sharp Plaza, Mahwah, New Jersey 07430 for 12,000 copies per month at a rental fee of \$207.13 for a forty-eight (48) month period in an amount not to exceed \$9,942.24; and

WHEREAS, funds in an amount not to exceed \$1,449.91 have been certified to be available in account number 5-01- - 25-2530-235 (November 2014 –June 2015), 6-01- - 25-2530-235 (\$2,485.56), 7-01- - 25-2530-235 (\$2,485.56) and 8-01- - 25-2530-235 (\$2,485.56) contingent upon the approval of the 2015, 2016, 2017 and 2018 temporary and final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

- The Purchasing Agent is hereby authorized to execute a purchase order for \$207.13 per month for forty-eight (48) months for Sharp Electronics, Corp, One Sharp Plaza, Mahwah, New Jersey 07430 for the rental of One (1) Sharp MX-M464N Networked Digital Copier, Scanner, Printer with all parts, labor, toner and drums for the Division of Purchasing.
- The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
