RESOLUTION AUTHORIZING THE PURCHASE OF A TRANSPORT VEHICLE FOR THE TRENTON POLICE DEPARTMENT TO MALL CHEVROLET, 75 HADDONFIELD ROAD, CHERRY HILL, NEW JERSEY 08002 THROUGH NEW JERSEY STATE CONTRACT NO. T-2006 NO. 88229 IN AN AMOUNT NOT TO EXCEED \$32,094.85.

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2006/No. 88229 for Vehicle Passenger Van, 8/12/15- Passenger from December 3, 2014 to December 2, 2016 meeting the requirements of the City of Trenton, Police Department; and

WHEREAS, a Transport Vehicle for Trenton Police Department will be purchased under New Jersey State T-2006 No. 88229 from Mall Chevrolet 75 Haddonfield Road Cherry Hill, New Jersey 08002 in an amount not to exceed of \$32,094.85; and

WHEREAS, funds in an amount not to exceed \$32,094.85 have been certified to be available in account number (s) G-FF-15-50-371G-410.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Mall Chevrolet 75 Haddonfield Road Cherry Hill, New Jersey 08002 in an amount not to exceed \$32,094.85, for the purchase of a transport vehicle for the City of Trenton, Police Department.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
