**RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2017 FORD F-250 4WD PICK UP TRUCK OR EQUIVALENT FOR THE DIVISION OF SOLID WASTE FROM CHAS S. WINNER, D/B/A/ WINNER FORD, 250 BERLIN ROAD, CHERRY HILL, NEW JERSEY 08034 THROUGH NEW JERSEY STATE CONTRACT NO. T2100 A88726 IN AN AMOUNT NOT TO EXCEED \$28,600.00**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2100 No. A88726 for Vehicles, Sport Utility Vehicles from March 26, 2015 to March 25, 2017 meeting the requirements of the City of Trenton; and

**WHEREAS**, one (1) 2017 Ford F-250 4WD Pick Up Truck or Equivalent for the Division of Solid Waste will be purchased under New Jersey State Contract T2100 No. A88726 from Chas S. Winner D/B/A Winner Ford, 250 Berlin Rd, Cherry Hill, NJ 08034 in an amount not to exceed of \$28,600.00; and

**WHEREAS**, funds in an amount not to exceed \$28,600.00 have been certified to be available in account number C-04-08-55-079L-003 budget.

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Chas S. Winner, D/B/A Winner Ford, 250 Berlin Road, Cherry Hill, NJ 08034 in an amount not to exceed \$28,600.00 for the City of Trenton, Department of Public Works, Division of Solid Waste.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
