





Councilman / woman George Muschal presents the following Resolution:

**RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) RED 2014 FORD F250 PICK-UP TRUCKS WITH ADDITIONAL EQUIPMENT FROM WINNER FORD, 250 BERLIN ROAD, CHERRY HILL, NEW JERSEY 08034 THROUGH NEW JERSEY STATE CONTRACT T-2100 A83576 FROM FEBRUARY 22, 2013 THROUGH DECEMBER 21, 2014 FOR THE FIRE DEPARTMENT IN AN AMOUNT NOT TO EXCEED \$99,785.38**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items /services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2100 No.A83576 for vehicles, trucks, class 2, pick-up/utility, with snow plow option from February 22, 2013 through December 21, 2014 meeting the requirements of the City of Trenton, Fire Department; and

**WHEREAS**, two (2) Red 2014 Ford F250 pick-up trucks with required equipment shall be purchased under New Jersey State Contract T-2100 No A83576 from Winner Ford, 250 Berlin Road, Cherry Hill, NJ 08034 in the amount of \$49,892.69 per equipment, in an amount not to exceed \$99,785.38; and

**WHEREAS**, funds in an amount not to exceed \$99,785.38 have been certified to be available in account C-04-15-45-040G-004 (\$42,274.25), C-04-15-45-040G-006 (\$42,274.25), (C-04-06-25-086L-024 (\$1,992.39), C-04-07-45-102K-016 (\$12,819.33) and C-04-06-25-086L-018 (\$425.16).


**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:


1. The Purchasing Agent is hereby authorized to execute a purchase order in an amount not to exceed \$99,785.38 for Winner Ford, 250 Berlin Road, Cherry Hill, NJ 08034 for the purchase of two (2) Red 2014 Ford F250 pick-up trucks with additional equipment for the Trenton Fire Department.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
