610 PLUM STREET, TRENTON, NEW JERSEY 08638 FOR THE FURNISHING AND
DELIVERY OF NON-OEM AUTO PARTS AND ACCESSORIES FOR LIGHT DUTY VEHICLES
ON AN AS NEEDED BASIS FOR MULTIPLE DEPARTMENTS OF THE CITY OF TRENTON
FROM STATE CONTRACT NO. T-2761 A86059 FROM AUGUST 1, 2016 TO
FEBRUARY 25, 2017 IN AN AMOUNT NOT TO EXCEED \$43,800.00**
