**RESOLUTION REJECTING BIDS RECEIVED FOR THE FURNISHING AND DELIVERY
OF VEHICLE PARTS, MAINTENANCE, REPAIR SERVICES, AND COLLISION REPAIRS
FOR HEAVY-DUTY CONSTRUCTION VEHICLES, FOR A PERIOD OF
ONE (1) YEAR WITH AN OPTION TO EXTEND ONE (1) ADDITIONAL YEAR FOR
THE CITY OF TRENTON, DEPARTMENT OF WATER AND SEWER,
TRENTON WATER WORKS- BID2025-61**

WHEREAS, three (3) sealed bids were received on June 26, 2025, at 11:00 am by the Purchasing Agent in the Division of Purchasing; for the Furnishing and Delivery of Vehicle parts, maintenance, repair services, and collision repairs for heavy-duty construction vehicles for a period of one (1) year with an option to extend one (1) year for the City of Trenton, Department of Water and Sewer, Trenton Water Works; and

WHEREAS, the following bids were received from Anthony Yaros Industries LLC, 350 Basin Road, Trenton, NJ, DPF Services LLC, 5C Dutch Court, Reading, PA 19608, and Creston Hydraulics, Inc., 53 Flock Rd, Hamilton, NJ 0865; and

WHEREAS, Trenton Water Works researched the bidder's website for Anthony Yaros Industries LLC, and found the bidder not qualified or experienced for having consistently performed repair work on heavy-duty construction vehicles for any municipality entity. DPF Services LLC did not fill out the specific services in bid specifications but instead supplied prices for different unrelated items. While competently qualified, Creston Hydraulics, Inc., only filled out 3 of 31 items listed on bid proposal form. As listed in the bid specifications under IX, rejection of bids part C, this would be considered as an un-balanced bid and reason for rejection; and

WHEREAS, pursuant to N.J.S.A 40A:11-13.2(d) allows the City of Trenton, Department of Water and Sewer to reject bids when the contacting unit wants to substantially revise the specifications for the goods or services. It is in the best interest of the City of Trenton, Department of Water and Sewer to reject bids received and re-advertise the procurement process.

NOW, THEREFORE, IT IS RESOLVED by the City Council of Trenton, that the bids received be rejected and the Division of Purchasing will re-advertise the procurement process.
