WHEREAS, one (1) sealed Request for Proposal was received in the Division of Purchasing on May 30, 2025, at 11:00a.m. by the Purchasing Agent for RFP2025-16 for Planning and Design Grant - Program and data Organizational Support for Trenton Water Works Lead Service Line Replacement Projects (LSLRPS); for a period of one (1) year for Trenton Water Works, Department of Water and Sewer; and


WHEREAS, the sole proposal received from CDM Smith Inc., 110 Fieldcrest Ave, 6th Floor, Edison, NJ 08837 in the amount of \$1,996,495.00 shall be deemed rejected. Pursuant to Local Public Contract Law N.J.S.A. 40A:11-23.2(e), allows the City of Trenton, Trenton Water Works, Department of Water and Sewer to reject proposals without the bidder's receipt of addenda to the advertisement. Failure to submit this acknowledgement shall be deemed a fatal defect and shall render the bid proposal unresponsive and that cannot be cured by the governing body.


