RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT AWARDED TO RESCUE MISSION OF TRENTON FOR EMERGENCY SHELTER FOR HOMELESS SINGLE INDIVIDUALS FOR A PERIOD OF ONE (1) YEAR FROM MARCH 9, 2025, TO MARCH 8, 2026, IN AN AMOUNT NOT TO EXCEED \$275,000.00 - CC2022-07

WHEREAS, on March 9, 2023, Resolution No. 23-092 awarded a contract to Rescue Mission of Trenton, 98 Carroll Street, Trenton, New Jersey 08609 for Emergency Shelter for Homeless Single Individuals for the City of Trenton, New Jersey for a period of one (1) year in an amount not to exceed \$275,000.00 with an option to extend two (2) one (1) year contract extensions for the City of Trenton, Department of Health and Human Services, Division of Community Relations and Social Services; and

WHEREAS, pursuant to N.J.S.A. 40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, The City of Trenton, Department of Health and Human Services has determined that Rescue Mission of Trenton, 98 Carroll Street, Trenton, New Jersey 08609 for Emergency Shelter for Homeless Single Individuals has performed in a satisfactory manner and it is in the best interest of the city to exercise the option to extend the contract for an additional one (1) year from March 9, 2025 to March 8, 2026; and

WHEREAS, funds in an amount not to exceed \$275,000.00 have been certified to be available in the following account number: 5-01- -40-4052-299. This contract shall be awarded from March 9, 2025 to March 8, 2026; and

THE AGREEMENT made this 8TH day of AUGUST 2025, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **RESCUE MISSION OF TRENTON, 98 CARROLL STREET, TRENTON, NEW JERSEY 08609** (hereinafter "CONTRACTOR")
