In accordance with the Federal regulations at 24 CFR, Part 91, notice is hereby given that the City of Trenton will hold a public hearing on **October 23, 2025 at 5pm** to solicit comments on the Consolidated Annual Performance Evaluation Report (CAPER) for FY 2024 which covers the program period from July 1, 2024, to June 30, 2025. The public is cordially invited to attend and participate in the hearing, which will be held both in person at Trenton City Hall in the Department of Recreation's 1<sup>st</sup> floor Conference Room, located at 319 East State Street, Trenton, NJ 08608 and virtually via the GoTo Meeting platform. The City of Trenton has prepared the FY 2024 CAPER in accordance with Title I of the National Affordable Housing Act of 1990, P.L. 101-625, and the regulations at 24 CFR Part 91.250. The City of Trenton's Department of Health and Human Services has prepared its Consolidated Annual Performance Evaluation Report (CAPER) for the year July 1, 2024, to June 30, 2025.

The report information includes: 1) Details of funds received from HUD for the Community Development Block Grant (CDBG) Program, the HOME Investment Partnerships Program (HOME), and the Emergency Solutions Grant (ESG) Program; 2) Summary of resources and accomplishments; 3) Status of actions taken during the year to implement the goals outlined in the Consolidated Plan; and 4) Evaluation of the progress made in addressing identified priority needs and objectives.

In addition, the regulations at 24 CFR 91.105 require a public comment period of not less than 15 days. Therefore, the City is making this report available to the public for comment from October 15, 2025 through October 30, 2025.
