RESOLUTION AUTHORIZING THE OPTION TO EXTEND A CONTRACT FOR ONE YEAR TO THATCHER COMPANY OF NEW YORK INC., PO BOX 27407, SALT LAKE CITY, UT 84127-0407 FOR THE FURNISHING AND DELIVERY F.O.B. OF COPPER SULFATE ON AS NEEDED BASIS FOR TRENTON WATER UTILITY IN AN AMOUNT NOT TO EXCEED \$36,980.00 FROM AUGUST 9, 2016 TO AUGUST 8, 2017-BID2015-35

WHEREAS, Resolution Number 15-491 awarded a contract on August 8, 2015 to Thatcher Company of New York Inc., PO Box 27407 Salt Lake City, UT 84127-0407 in an amount not to exceed \$36,980.00 from August 7, 2015 to August 8, 2016 with an option to extend one year in an amount not to exceed \$36,980.00; and

WHEREAS, N.J.S.A.40A:11-15 provides that service contracts may be extended for no more than (1) one two-year or (2) two one-year extensions; and

WHEREAS, the City of Trenton, Department of Public Works has determined that Thatcher Company of New York Inc., has performed its services in a satisfactorily manner and it is in the best interest of the City to extend the contract for one year with Thatcher Company of New York Inc., PO Box 27407, Salt Lake City, UT 84127-0407 per N.J.S.A.40A:00-11-15. The one year renewal will commence on August 9, 2016 and expire on August 8, 2017; and





BID2015-35
CONTRACT EXERCISING THE OPTION TO EXTEND WITH THATCHER COMPANY OF
NEW YORK, INC.**

THE AGREEMENT made this 22ND day of JULY 2016, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **THATCHER COMPANY OF NEW YORK, INCORPORATED, P.O. BOX 27407, SALT LAKE CITY, UT 84127-0407** (hereinafter "CONTRACTOR")

WHEREAS, Res. No. 15-491 awarded a contract to Thatcher Company of New York, Inc., P.O. Box 27407, Salt Lake City, UT 84127-0407 for the furnishing and delivery of F.O.B. of Copper Sulfate on an as needed basis for the City of Trenton, Department of Public Works, Trenton Water Utility in an amount not to exceed \$36,980.00 from August 7, 2015 to August 8, 2016; and

WHEREAS, Resolution 16-392 authorized the option to extend the contract for one year per the original bid and specifications filed in the Division of Purchasing.

NOW THEREFORE, the parties mutually agree as follows:

1. The amount of the option to extend one (1) year agreement shall be in an amount not to exceed \$36,980.00 beginning August 9, 2016 to August 8, 2017.
2. The Mayor is hereby authorized to extend the contract for one (1) year to Thatcher Company of New York, Inc., P.O. Box 27407, Salt Lake City, UT 84127-0407.
