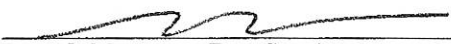

RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR ONE YEAR WITH DAVID WEBER OIL COMPANY, 601 INDUSTRIAL ROAD, CARLSTADT, NEW JERSEY 07072 FOR THE FURNISHING AND DELIVERY OF OIL AND GREASE ON AN AS NEEDED BASIS FOR VARIOUS DIVISIONS OF THE CITY OF TRENTON FROM STATE CONTRACT NO. T-0097 A81519 IN AN AMOUNT NOT TO EXCEED \$40,000.00 FROM MAY 30, 2015 TO MAY 29, 2016

WHEREAS, Resolution Number 14-434 awarded a contract to David Weber Oil Co., for the furnishing and delivery of oil and grease on an as needed basis for various divisions for the City of Trenton for a period of one year from July 1, 2014 to May 29, 2015; and

WHEREAS, the City of Trenton, Department of Administration, has determined that David Weber Oil Co, 601 Industrial Road, Carlstadt, New Jersey 07072 has performed its services in a satisfactorily manner and it is the best interest of the City to exercise the option to extend the contract for the second year on an as needed basis through New Jersey State Contract No.T-0097 A81519; and

WHEREAS, the Division of Purchasing has reviewed and verified through New Jersey State Contract No. T-0097 A81519 for Automotive Lubricants: Engine/Gear Oils, Greases, ATF, Tractor Fluid & HYD Oils from May 30, 2012 to May 29, 2016 meeting the requirements of the City of Trenton; and

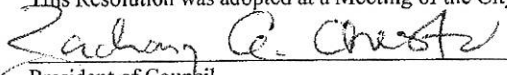
NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

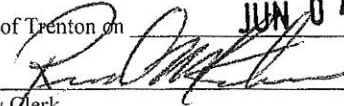

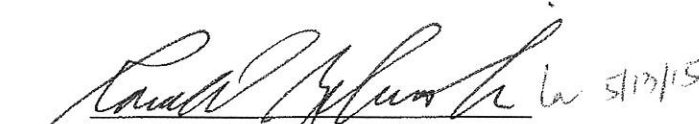
