RESOLUTION AWARDING A CONTRACT TO DAVID WEBER OIL COMPANY, 601 INDUSTRIAL ROAD, CARLSTADT, NEW JERSEY 07072 FOR THE FURNISHING AND DELIVERY OF OIL AND GREASE ON AN AS NEEDED BASIS FOR VARIOUS DIVISIONS OF THE CITY OF TRENTON FROM STATE CONTRACT NO. T-0097 A81519 IN AN AMOUNT NOT TO EXCEED \$50,000.00 FROM MAY 30, 2016 TO MAY 29, 2017

WHEREAS, Resolution Number 15-274 exercising the option to extend a contract to David Weber Oil Co., for the furnishing and delivery of oil and grease on an as needed basis for various divisions for the City of Trenton for a period of one year from May 30, 2015 to May 29, 2016 in an amount not to exceed \$40,000.00; and

WHEREAS, the City of Trenton, Department of Administration, has determined that David Weber Oil Co, 601 Industrial Road, Carlstadt, New Jersey 07072 has performed its services in a satisfactorily manner and it is the best interest of the City to award a contract for the a period of one year on an as needed basis through New Jersey State Contract No.T-0097 A81519 from May 30, 2016 to May 29, 2017; and


