**RESOLUTION AUTHORIZING THE PURCHASE OF TWO (2) 2016 BLACK FORD EXPLORERS, K8B, 4 DOOR, 4X4 FOR THE DEPARTMENT OF HEALTH AND HUMAN SERVICES AWARDED TO BEYER FORD, 170 RIDGEDALE AVENUE, MORRISTOWN, NJ 07960 THROUGH NEW JERSEY STATE CONTRACT NO. T-2007 A83013 IN AN AMOUNT NOT TO EXCEED \$49,416.00**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2007 No. A83013 awarded to Beyer Ford, 170 Ridgedale Ave, Morristown, NJ 07960 for Vehicles, Sport Utility Vehicles from October 30, 2012 to October 29, 2016 meeting the requirements of the City of Trenton, Department of Health and Human Services; and

**WHEREAS**, two (2) 2016 Black Ford Explorers for the Department of Health and Human Services will be purchased under New Jersey State Contract T-2007 No. A83013 from Beyer Ford, 170 Ridgedale Ave, Morristown, NJ 07960 in an amount not to exceed of \$49,416.00; and

**WHEREAS**, funds in an amount not to exceed \$49,416.00 have been certified to be available in account number (s) C-04-16-40-035L-003 (\$24,708.00) and C-04-16-40-035L-004 (\$24,708.00).

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Beyer Ford, 170 Ridgedale Ave, Morristown, NJ 07960 in an amount not to exceed of \$49,416.00 for the purchase of two (2) 2016 Black Ford Explorers for the City of Trenton, Department of Health and Human Services.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
