WINNER, D/B/A/ WINNER FORD, 250 BERLIN ROAD, CHERRY HILL, NEW JERSEY 08034 THROUGH NEW JERSEY STATE CONTRACT T-2100 NO. A88726 IN AN AMOUNT NOT TO EXCEED \$37,719.00

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2100 No. A88726 for Vehicles, Trucks, Class 2, Pickup/Utility, with Snow Plow Option from March 26, 2015 to March 25, 2017 meeting the requirements of the City of Trenton; and



