RESOLUTION EXERCISING THE OPTION TO EXTEND THE CONTRACT FOR TWO YEARS WITH ACCURATE WASTE REMOVAL SERVICES, 226 PROSPECT POINT ROAD, LAKE HOPATCONG, NEW JERSEY 07849 FOR DAILY WASTE REMOVAL AND DISPOSAL OF LIQUID SLUDGE FROM DIGESTER TANKS IN AN AMOUNT NOT TO EXCEED \$1,077,440.00 PER YEAR-BID2015-41

WHEREAS, Resolution 15-577 awarded a contract on September 17, 2015 to Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey for a period of two (2) years for daily removal and disposal of liquid sludge from Digester Tanks, in an amount not to exceed \$1,077,440.00 for the Department of Public Works, Division of Sewer Utility; and

WHEREAS, Resolution 16-256 amended Resolution 15-577 in order to accurately reflect the original bid specification, which stipulated the contract would be for a period of two (2) years with an option for one additional two (2) year extension as is allowed per N.J.S.A. 40A:11-15 the terms and conditions of the contract remain substantially the same; and

WHEREAS, The current two (2) year contract for said services is due to expire on September 17, 2017, the vendor, Accurate Waste Removal Services has indicated by Letter of Agreement its desire to continue to provide Daily Waste and Removal Services for two (2) additional years under the auspices of the original bid documents beginning September 17, 2017 to June 30, 2019; and

WHEREAS, Funding for these services will be available in budget account (s) 8-07- -55-5500-289 (\$1,077,440) from September 17, 2017 to June 30, 2018; 9-07- -55-5500-289 (\$1,077,440.00) beginning July 1, 2018 to June 30, 2019 contingent upon the adoption of FY'2018 and FY'2019 temporary and or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to exercise the option to extend the contract for two (2) years, with Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey 07849 for the said purposes in the manner prescribed by law.

**RESOLUTION # 17-215
EXERCISING THE OPTION TO EXTEND A CONTRACT
WITH ACCURATE WASTE REMOVAL SERVICES
BID2015-41**

THE AGREEMENT made this 5TH Day of MAY 2017, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **ACCURATE WASTE REMOVAL SERVICES, 226 PROSPECT POINT ROAD, LAKE HOPATCONG, NEW JERSEY 07849** (hereinafter "CONTRACTOR")

WHEREAS, Resolution No. 15-577 dated September 17, 2015, awarded a contract to Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey 07849 for a period of two (2) years from August 7, 2015 to September 16, 2017 in an amount not to exceed \$1,077,440.00; for daily removal and disposal of liquid sludge from Digester Tanks for the City of Trenton for the Department of Public Works, Division of Sewer Utility.

WHEREAS, Resolution No. 16-256 amended Resolution No. 15-577 in order to accurately reflect the original bid specification, which stipulated the contract would be for a period of two (2) years with an option for one (1) additional two (2) year extension in an amount not to exceed \$1,077,440.00; per N.J.S.A. 40A:11-15 the terms and conditions of the contract remain substantially the same; and

WHEREAS, Resolution No. 17-215 dated May 2, 2017, authorized to exercise the option to extend the contract for two (2) additional years from September 17, 2017 to June 30, 2019 in an amount not to exceed \$1,077,440.00; per the original bid specifications filed in the Division of Purchasing.

NOW THEREFORE, the parties mutually agree as follows:


1. The amount of the agreement shall be in an amount not to exceed \$1,077,440.00 from September 17, 2017 to June 30, 2019.
2. The Mayor is hereby authorized to exercise the option to extend contract for two (2) years, with Accurate Waste Removal Services, 226 Prospect Point Road, Lake Hopatcong, New Jersey 07849 from September 17, 2017 to June 30, 2019 for said purposes in the manner prescribed by law.
