**RESOLUTION AUTHORIZING CHANGE ORDER #1  
TO THE CONTRACT WITH ZOMPARELLI CONTRACTORS, LLC, FOR THE  
CONSTRUCTION OF ADA COMPLIANT RAMPS AT VARIOUS LOCATIONS  
WITHIN THE CITY OF TRENTON FOR THE DEPARTMENT OF PUBLIC  
WORKS**

**WHEREAS**, Resolution 17-322 authorized a contract in the amount of \$295,542.65 with Zomparelli Contractors, LLC, 11 Michael McCorriston Road, Trenton, New Jersey 08690 for Bid Number 2017-06 for the furnishing and delivery of all labor, equipment and materials for Construction of ADA Compliant Ramps at Various Locations Within the City of Trenton for The Department of Public Works; and

**WHEREAS**, there is a need to install additional ADA compliant ramps in an effort to remain in compliance with the City's agreement with the New Jersey Protection Advocacy Group; and

**WHEREAS**, the changes will not alter the contract in such a manner as to nullify the effect of the competitive determination of lowest responsible bidder which was made at the time of the contract award; and

**WHEREAS**, the amount of this change order is \$59,000.00. Previous change orders have been authorized in the amount of \$0; and

**WHEREAS**, funds have been certified to be available in account number C-04-15-65-040A-001.

**IT IS FURTHER RESOLVED**, that a brief notice shall be printed once in an official newspaper and filed with the City Clerk indicating the additional amount to be expended, the original contract price, the nature of the original and additional work, and why it is necessary to expend the additional funds.

**IT IS FURTHER RESOLVED**, notice of this change order shall be filed on an Appendix to the Annual Budget and included as supplemental material in the Annual Audit.

CHANGE ORDER #1  
BID2017-06**

**THE AGREEMENT** made this 19<sup>TH</sup> day of JANUARY 2018, by and between the **CITY OF TRENTON**, a municipal corporation, of the State of New Jersey, with principal offices located at **319 EAST STATE STREET, TRENTON, NEW JERSEY 08608** (hereinafter the "City") and **ZOMPARELLI CONTRACTORS, LLC, 11 MICHAEL MCCORRISTON ROAD, TRENTON, NEW JERSEY 08690** (hereinafter "CONTRACTOR")

**WHEREAS**, Resolution 17-322 awarded a contract on June 1, 2017 to Zomparelli Contractors, LLC, 11 Michael McCorriston Road, Trenton, New Jersey 08690 for the Construction of ADA Compliant Ramps as Directed at Various Locations within the City of Trenton in an amount not to exceed \$295,542.62 for a Period of One (1) Year from date of Execution or until budgeted dollar limit of this contract have been expended for the City of Trenton, Department of Public Works, Division of Traffic and Transportation; and

**WHEREAS**, Resolution No. #17-813 dated January 19, 2018, authorized Change Order No. #1 in an amount not to exceed \$59,000.00; per the original bid specifications filed in the Division of Purchasing.

**NOW THEREFORE**, the parties mutually agree as follows:

1. The amount of the agreement shall be in an amount not to exceed \$59,000.00. No previous change orders have been authorized. The grand total of the project with the change order amount is \$354,542.62.
2. The Mayor is hereby authorized Change Order No. #1 with Zomparelli Contractors, LLC, 11 Michael McCorriston Road, Trenton, New Jersey 08690 for said purposes in the manner prescribed by law.
