

RESOLUTION AUTHORIZING THE PURCHASE AND INSTALLATION OF FIVE (5) RUGGED LAPTOP COMPUTERS WITH REQUIRED ACCESSORIES FROM GOLD TYPE BUSINESS MACHINES, INCORPORATED, 351 PATERSON AVENUE, EAST RUTHERFORD, NEW JERSEY 07073 THROUGH NEW JERSEY STATE CONTRACT NO. M-0483 89980 IN AN AMOUNT NOT TO EXCEED \$24,157.73

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract M-0483 89980 for NASPO Valuepoint Computer awarded from October 1, 2015 to March 31, 2017 which meets the requirements of the City of Trenton, Department of Health and Human Services, Division of Animal Control in an amount not to exceed \$24,157.73; and



WHEREAS, the purchase and installation of five (5) rugged laptop computers with required accessories shall be purchased from Gold Type Business Machines, Inc., 351 Paterson Ave, E. Rutherford, NJ 07073 in the amount not to exceed \$24,157.73 for the City of Trenton, Department of Health and Human Services, Division of Animal Control; and

WHEREAS, funds in an amount not to exceed \$24,157.73 have been certified to be available in account number (s) T-12-DL-40-2210-001 (\$16,957.73); C-04-16-40-35D-001 (\$7,200.00).

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order to Gold Type Business Machines, Inc., 351 Paterson Ave, E. Rutherford, NJ 07073 in the amount not to exceed \$24,157.73 for the City of Trenton, Department of Health and Human Services, Division of Animal Control from December 23, 2016 to March 31, 2017.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
