RESOLUTION AUTHORIZING A CONTRACT EXTENSION WITH ACRO SERVICE CORPORATION, 39209 WEST SIX MILE ROAD, SUITE 250, LIVONIA, MICHIGAN 48152 TO PROVIDE TEMPORARY STAFFING SERVICES THROUGH NEW JERSEY STATE CONTRACT NO. M-2001 83534 IN AN AMOUNT NOT TO EXCEED \$75,000.00

WHEREAS, Resolution 16-487 awarded a contract extension on August 16, 2016 with Acro Service Corporation to provide Temporary Staffing Services for various departments throughout the City of Trenton in an amount not to exceed \$120,000.00 from April 1, 2016 to March 31, 2017; and

WHEREAS, New Jersey State Contract M-2001 83534 awarded to Acro Service Corp, has been extended from April 1, 2017 to March 31, 2018. The Division of Purchasing has reviewed and verified New Jersey State Contract M-2001 83534 for Temporary Staffing Services meeting the requirements of the City of Trenton, Department of Public Works, Trenton Water Utility and the Water Filtration Plant; and

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to utilize temporary staff services without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the City of Trenton, Department of Public Works, Division of Trenton Water Utility and the Water Filtration Plant has a severe shortage until adequate permanent staffing levels can be met; and

WHEREAS, funds in an amount not to exceed \$75,000.00 have been certified to be available in account number 7-05 - -55-5500-899-009 (\$25,000.00) beginning April 1, 2017 to June 30, 2017; 8-05 - - 55-5500-899-009 (\$50,000.00) beginning July 1, 2017 to March 31, 2018 contingent upon the adoption FY'2018 temporary and or final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to extend the contract with Acro Service, Corp., 32909 W. Six Mile Rd., Suite 250, Livonia, MI 48152 from April 1, 2017 to March 31, 2018 in an amount not to exceed \$75,000.00 for the City of Trenton, Department of Public Works, Trenton Water Utility and the Trenton Water Filtration Plant for the said purposes in the manner prescribed by law.
