**RESOLUTION AUTHORIZING A CONTRACT TO ATLANTIC TACTICAL OF NJ, INC., 14 WORLDS FAIR DRIVE, SOMERSET, NEW JERSEY 08873 TO PURCHASE SWAT TEAM BALLISTIC SAFETY EQUIPMENT THROUGH NEW JERSEY STATE CONTRACT NO. T-0106 A82102 IN AN AMOUNT NOT TO EXCEED \$76,052.00**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0106 A82102 for Police and Homeland Security Equipment and Supplies awarded to Atlantic Tactical of NJ, Inc., 14 Worlds Fair Drive, Somerset, New Jersey 08873 from August 01, 2012 to August 28, 2017 as the requirements of the City of Trenton, Department of Police; and

**WHEREAS**, Swat Team Ballistic Equipment shall be purchased from Atlantic Tactical of NJ, Inc., 14 Worlds Fair Drive, Somerset, New Jersey 08873 through New Jersey State Contract #T-0106 A82102 in an amount not to exceed of \$76,052.00; and

**WHEREAS**, funds in an amount not to exceed \$76,052.00 have been certified to be available in account number G-FF-17-50-372G-303.

**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order with Atlantic Tactical of NJ, Inc., 14 Worlds Fair Drive, Somerset, New Jersey 08873 in an amount not to exceed \$76,052.00, for the purchase of Swat Team Ballistic Equipment for the City of Trenton, Department of Police.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
