RESOLUTION AUTHORIZING A CONTRACT TO CAROUSEL INDUSTRIES, 1160 STILFORD AVENUE, PLAINFIELD, NEW JERSEY 07060 TO PROVIDE ANNUAL MAINTENANCE SERVICES FOR THE E911 PATRIOT TELEPHONE SYSTEM THROUGH NEW JERSEY STATE CONTRACT NO. T-0109 A83925 IN AN AMOUNT NOT TO EXCEED \$91,970.28

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract No. T-0109 A83925 for Data Communications Network Services awarded to Carousel Industries, 1160 Stilford Avenue, Plainfield, New Jersey 07060 from February 11, 2014 to February 10, 2019 as the requirements of the City of Trenton, Department of Police; and

WHEREAS, Annual Maintenance for the E911 Patriot Telephone System shall be provided by Carousel Industries, 1160 Stilford Avenue, Plainfield, New Jersey 07060 through New Jersey State Contract #T-0109 A83925 in an amount not to exceed of \$91,970.28 from July 1, 2017 to June 30, 2018; and

WHEREAS, funds in an amount not to exceed \$91,970.28 have been certified to be available in account number 8-01- -50-5010-270 contingent upon FY 2018 temporary/final budget.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order with Carousel Industries, 1160 Stilford Avenue, Plainfield, New Jersey 07060 in an amount not to exceed \$91,970.28, for Annual Maintenance for the Communications Division's E911 Patriot Telephone System of the City of Trenton, Department of Police.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
