RESOLUTION AUTHORIZING A CONTRACT TO BUCKS COUNTY INTERNATIONAL INC., 134 OLD OXFORD VALLEY ROAD, LANGHORNE, PA 19047 FOR MAINTENANCE AND REPAIR OF ONE (1) INTERNATIONAL MODEL 7500 SFA 6X4 HEAVY DUTY VEHICLE THROUGH NEW JERSEY STATE CONTRACT NO. T-2108 A89268 IN AN AMOUNT NOT TO EXCEED \$11,934.69

WHEREAS, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

WHEREAS, the Division of Purchasing has reviewed and verified New Jersey State Contract# T-2108 A89268 for Maintenance and Repair of One (1) International Model 7500 SFA 6X4 awarded to Bucks County International Inc., 134 Old Oxford Valley Road, Langhorne, PA 19047 from July 21, 2015 to July 20, 2018 meeting the requirements of the City of Trenton, Department of Public Works, Division of Streets; and

WHEREAS, Maintenance and Repair of One (1) International Model 7500 SFA 6X4 Heavy Duty Vehicle shall be provided by from Bucks County International Inc., 134 Old Oxford Valley Road, Langhorne, PA 19047 through State Contract# T-2108 A89268 for the City of Trenton, Department of Public Works, Division of Streets in an amount not to exceed of \$11,934.69; and

WHEREAS, funds in an amount not to exceed \$11,934.69 have been certified to be available in account number 7-01- -55-5520-425.

NOW, THEREFORE, IT IS RESOLVED, by the City of Council of the City of Trenton as follows:

1. The Purchasing Agent is hereby authorized to execute a purchase order with Bucks County International Inc., 134 Old Oxford Valley Road, Langhorne, PA 19047 for the Maintenance and Repair of One (1) International and Model 7500 SFA 6X4 Heavy Duty Vehicle in an amount not to exceed \$11,934.69 for the City of Trenton, Department of Public Works, Division of Streets.
2. The contract is awarded without competitive bidding pursuant to N.J.S.A.40A:11-12(a) of the Local Public Contracts Law.
