





**RESOLUTION AUTHORIZING THE PURCHASE OF ONE (1) 2017 FORD TRANSIT OR EQUIVALENT FOR THE DEPARTMENT OF RECREATION, NATURAL RESOURCES & CULTURE TO BEYER FORD, 170 RIDGEDALE AVENUE, MORRISTOWN, NJ 07960 THROUGH NEW JERSEY STATE CONTRACT T-2006 NO. A88231 IN AN AMOUNT NOT TO EXCEED \$30,415.00**

**WHEREAS**, N.J.S.A. 40A:11-12 (a) permits the City of Trenton to purchase items without the necessity of competitive bidding under the State of New Jersey Cooperative Purchasing Program; and

**WHEREAS**, the Division of Purchasing has reviewed and verified New Jersey State Contract T-2006 No. A88231 for Vehicles, Passenger Vans, 8/12/15-Passenger from December 3, 2014 to December 2, 2016 meeting the requirements of the City of Trenton, Department of Recreation, Natural Resources and Culture; and

**WHEREAS**, one (1) 2017 Ford Transit or Equivalent for the Department of Recreation, Natural Resources and Culture will be purchased under New Jersey State Contract T-2006 No. A88231 from Beyer Ford, 170 Ridgedale Ave, Morristown, NJ in an amount not to exceed \$30,415.00; and

**WHEREAS**, funds in an amount not to exceed \$30,415.00 have been certified to be available in account number C-04-08-70-079L-010.


**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:


