


**RESOLUTION AUTHORIZING A CONTRACT WITH GOLDEN CROWN CONTRACTORS, INCORPORATED, 4099 SOUTH BROAD STREET, YARDVILLE, NEW JERSEY 08620 FOR FACILITY REPAIRS AT THE K-9 TRAINING FACILITY, 1277 EAST STATE STREET, TRENTON, NEW JERSEY 08611 IN CONJUNCTION WITH THE COUNTY OF MERCER COOPERATIVE CONTRACT PURCHASING SYSTEM AGREEMENT CK09MERCER2016-16 IN AN AMOUNT NOT TO EXCEED \$15,999.00**

**WHEREAS**, Golden Crown Contractors, Inc. is a vendor under the Mercer County Cooperative Purchasing System CK09MERCER2016-16 and has submitted a quote to perform facility repairs at the K-9 Training Facility, 1277 E. State Street, Trenton 08611 for the City of Trenton of Police; and


**WHEREAS**, funds in an amount not to exceed \$15,999.00 have been certified to be available in the following account: C-04-16-55-035A-009.


**NOW, THEREFORE, IT IS RESOLVED**, by the City Council of the City of Trenton as follows:
