RESOLUTION RESCINDING RESOLUTION NO. 15-691 AND CANCELING CONTRACT AWARDED TO YP CONSTRUCTION, INCORPORATED BID2015-76

WHEREAS, two (2) sealed bids were received on September 9, 2015 for the Purchase and Installation of One (1) Gas Powered Generator located at the West Ward Fire Station for the City of Trenton, Fire Department; and

WHEREAS, the City of Trenton has made several attempts to contact the awarded bidder, Johnny Zheng Of YP Construction Incorporated, 1582 Route 27, Edison, New Jersey 08817, who has relocated out of the country and cannot comply with the terms and conditions of the contract; and

WHEREAS, it is in the best interest of the City of Trenton to cancel the contract awarded to YP Construction and rescind Resolution No. 15-69, and thereafter, re-advertise this procurement; and
