

RESOLUTION REJECTING TWO (2) BIDS RECEIVED FOR EMERGENCY BOARDING AND SECURING OF VACANT PRIVATE PROPERTIES, REMOVAL OF HIGH GRASS, HIGH WEEDS AND REMOVAL OF DEBRIS THROUGHOUT THE CITY OF TRENTON-ADDITONAL BID- BID2017-74
