

RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WHICH WAS AWARDED THROUGH A FAIR AND OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44A-20.5 ET SEQ. WITH LYLE P. HOUGH, ESQ., 79 MORGAN AVENUE, YARDLEY, PA, 1906 TO PROVIDE PROSECUTORIAL SERVICES WITH REGARDS TO MATTERS CONCERNING THE TRENTON MUNICIPAL COURT IN AMOUNT NOT TO EXCEED \$21,500.00

WHEREAS, the City of Trenton has a continued need for prosecutorial services in the administrative office of the Trenton Municipal Court; and

WHEREAS, Resolution Number 18-598 awarded a contract to Lyle P. Hough, Esq. through RFP2018-17 in an amount not to exceed \$35,000.00; and

WHEREAS, previously allocated funds has been exhausted and additional funds are necessary to cover services rendered through June 30, 2019; and

WHEREAS, this amendment shall be awarded to Lyle P. Hough, Esq. in an amount not to exceed \$21,500.00; and

WHEREAS, funds for this contract have been certified to be available in the FY2019 Budget in Account Number 9-01- -35-3500-291;

NOW THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend the contract with Lyle P. Hough, Esq. for the said purposes in the manner prescribed by law.

AMENDMENT TO PROFESSIONAL LEGAL SERVICES AGREEMENT

THIS AMENDED AGREEMENT made this 19th day of August 2019, by and between the **CITY OF TRENTON**, a municipal corporation of the State of New Jersey, with its principal offices located at 319 East State Street, Trenton, New Jersey 08608 (hereinafter the "City") and **LYLE P. HOUGH, ESQ.**, 79 Morgan Avenue, Yardley, PA 19067

WHEREAS, based upon the number of hours expended in the 2019 fiscal contract year in the performance of Prosecutorial Services on behalf of the City; and

WHEREAS, the compensation initially allocated by the City to compensate you has been deemed to be insufficient to the end of the fiscal contract year; and

WHEREAS, pursuant to Resolution **19-432**, the city desires to increase the compensation under the current Professional Services Agreement for said services through June 30, 2019,

NOW THEREFORE, the parties mutually agree as follows:

1. The compensation in the amount of the Twenty One Thousand Five Hundred Dollars (\$21,500.00) represents final payment for services rendered through June 30, 2019.
