RESOLUTION AUTHORIZING AN AMENDMENT TO THE CONTRACT WHICH WAS AWARDED THROUGH A FAIR AND OPEN PROCESS IN ACCORDANCE WITH N.J.S.A. 19:44A-20.5 ET SEQ. TO THE LAW OFFICE OF DECOTIIS FITZPATRICK & COLE, LLP, GLENPOINTE CENTER WEST, 500 FRANK W. BURR BLVD., SUITE 31, TEANECK, NEW JERSEY FOR PROVIDING PROFESSIONAL LEGAL SERVICES REGARDING GENERAL MUNICIPAL AND DEFENSE LITIGATION MATTERS FOR THE CITY OF TRENTON IN AN AMOUNT NOT TO EXCEED \$2,237.11

WHEREAS, the City of Trenton has a continuing need for professional legal services regarding General Municipal and Defense Litigation matters: and

WHEREAS, Resolution Number 17-406 awarded a contract to DeCotiis Fitzpatrick & Cole, L.L.P. in an amount of \$50,000.00 through RFP2017-17. The contract was amended through Resolution Number 18-63 in an amount not to exceed \$40,000.00: and

WHEREAS, previously allocated funds has been exhausted and additional funds are necessary to cover services rendered through June 30, 2018: and

WHEREAS, this amendment shall be awarded to DeCotiis Fitzpatrick & Cole, LLP, in the amount of \$2,237.11 as final payment for fiscal year 2018; and

WHEREAS, funds for this contract amendment has been certified to be available in Account Number 8-01- -35-3500-290.

NOW, THEREFORE, IT IS RESOLVED, by the City Council of the City of Trenton that the Mayor is hereby authorized to amend the contract with DeCotiis Fitzpatrick & Cole, LLP, for the said purposes in the manner prescribed by law.
